Please note that we may change the rule, depending on the number of the team entries. Also, please understand that due to the limited number of courts that will be available for us, there may be a waiting time before and/or after your match. Your cooperation will be appreci-

ated.

Teams: Each team must consist of 4 players, but it is possible to register the 5th player as a back-up. The back-up player does

not need to pay the fee(s), but please note that only those whose names appear in the Registration Form below will be

eligible to play at this tournament.

TeamName Contest: On the day of the tournament, we will hold a contest for the most unique team name.

Facility Rule: No food is allowed in or consumed on the balcony of the 2 Fl. indoor courts. (You may eat on the first floor hallway.)
