Qualification: Registered Nippon Club members, employees of Nippon Club's bond holding companies,

Format: There will be three classes; Open A, Open B, and Women. (("Open" is for both men and women. The team can be

only men, only women or mixed. However, depending on the number of teams that enter the tournament, we may not have separate classes.) The team who wins two out of three games will win the match. Please note that we may change the rule, depending on the number of the team entries. Also, please understand that due to the limited number of courts that will be available for us, there may be a waiting time before and/or after your match. Your cooperation will be appreci-

ated.

Teams: Each team must consist of 4 players, but it is possible to register the 5th player as a back-up. The back-up player does

not need to pay the fee(s), but please note that only those whose names appear in the Registration Form below will be

eligible to play at this tournament.
